## VII. COMMITTEE REPORTS

#### 1. Community Relations Committee

Mrs. Madhukar reported that the Community Relations Committee met on March 18, 2021 at 5:30 P.M. at John P. Stevens High School. This was an Internal Meeting.

In attendance were: Shivi Madhukar, Carol Bodofsky, Elizabeth Conway, Virginia White, Edward Aldarelli, Ed.D., and Bernard F. Bragen, Jr., Ed.D.

#### Items Discussed:

- Mrs. Madhukar noted that the Community Relations Committee was first created in 2018; however, the Committee has never met. This year, the Committee was formed on February 3<sup>rd</sup>. Since this was a new committee and role was undefined, the first meeting focused on how to use this platform to create better transparency and communication with the Edison community, because even the best-laid plans can fail if not communicated properly.
- The Committee discussed how communication wan create a problem as well as be its solution.
- Since the focus is "community," the Committee discussed various formats to get the community involved in sharing knowledge and bringing transparency and discussed conducting internal meetings for organizing and discussing details on topics for open forums.
- The Committee discussed formats for involving the community at large. This included conducting meetings via zoom, in-person meetings in various schools, and focus groups with residents who are interested in contributing to developing the role of the committee.
- The Committee agreed on conducting monthly open forums.

- The Committee focused on questions related to school opening for the full day.

#### 3. Community Relations Committee

Mrs. Madhukar reported that the Community Relations Committee met on April 14, 2021 at 4:15 P.M. at the Education Center. This was an Internal Meeting.

In attendance were: Shivi Madhukar, Carol Bodofsky, Elizabeth Conway, Virginia White and Bernard F. Bragen, Jr., Ed.D.

#### Items Discussed:

- The role of the Committee was further honed and refined in this second Internal Meeting.
- The Committee discussed the committee as being a "thought-process" that will improve Edison schools in the long run.
- The Committee discussed using this forum to create a knowledge base. There are issues that may not have immediate resolution but understanding a problem is the beginning of finding a solution. Similarly, there are things that may be going very well (within a school or universally across the district); having knowledge of that helps in replicating best practices or concepts across all schools, as well as replicating it for other areas where it is currently not in practice.
- The Committee discussed using this forum as a platform where such ideas or issues could be brought to light and aggregated in one place for future action.
- There are many wonderful initiatives the board and the administration initiate; but these initiatives are often missed by the community.
- The Committee discussed using this forum to share and communicate those plans, proposals and programs.
- The Committee also discussed lessons learned from the first open forum on March 18<sup>th</sup> and ways to be more effective going forward.
- An open forum will be hosted by the Committee on May 4<sup>th</sup> at 7:00 P.M. via Zoom. Information on the meeting will be shared via email. It will also be available on the Board of Education website. Residents will be able to ask questions or share ideas live via Zoom.
- The Committee would welcome any ideas via email as well.

### 4. Curriculum & Technology Committee

Mrs. Peng reported that the Curriculum and Technology Committee met at 12:00 P.M. on April 15, 2021 via Zoom.

In attendance were: Shannon Peng, Dr. Yuna Chen, Mohin Patel, Shivi Madhukar, Gail Pawlikowski, Baninder Mahabir and Diane Braungard

#### Items Discussed:

- Summer Programs have been reviewed. Principals will be sharing with parents information about the available programs, and all programs will be listed on the District website.
- Educational Equity is a priority goal of the District. Equity in education requires putting systems in place to ensure that every child has an equal chance for success. That requires understanding the unique challenges and barriers faced by individual students or by populations of students and providing additional support to help them overcome those barriers.
- Edison's goal is to give every student an opportunity for success. The District is examining all systems and practices for fairness and inclusion: Fairness, which means ensuring that personal and social circumstances do not prevent students from achieving their academic potential; and Inclusion, which means setting a basic minimum standard for education that is shared by all students regardless of background, personal characteristics or location.
- The District is already revising the curriculum, gathering resources and providing staff development to begin the work toward educational equity.

#### 5. Finance & Facilities Committee

#### 6. Special Education Committee

Mrs. Conway reported that the Special Education Committee met at 2:00 P.M. on April 20, 2021 in the Education Center.

In attendance were: Elizabeth Conway, Carol Bodofsky, Dr. Yunxia Chen, Biral Patel, Christopher Conklin, Ed.D., Alison Hines, Erin Madera, Dawn Netzel and Nancy Sica.

## Items Discussed:

- Staffing Fully staffed with accommodations for those on leaves.
- ESY 2021 Will be in person unless there is a medical exception. It will take place from July 1<sup>st</sup> until the third week in August.
- The district programs will include Preschool Handicapped, Autistic, MD, Learning Language Disabilities and In-Class Resource. Only a few Resource Classes remain, but will eventually be discontinued.
- Edison employs an AAC Specialist who is instrumental for testing students with limited speech.
- The District continues the professional development using the New Jersey Council for Inclusive Education. Included programs are Jump Ahead, Cumberland Solutions and Phonics First.
- RWJ Barnabas Health Source provides PD for counsellors, CSTs and administrators.
- The Committee was advised that there is a law under consideration to up the age of students to be educated by one year.
- The NJSLA has been canceled. There may be a fall assessment (DLM) Dynamic Learning Maps.

The meeting was adjourned at 2:40 P.M.

#### 7. Township Liaison Committee

Mrs. White reported that the Township Liaison Committee met at 11:00 A.M. on April 9, 2021 in the Education Center.

In attendance were: Mohin Patel, Shivi Madhukar, Biral Patel, Virginia White, Bernard F. Bragen, Ed.D., Council: Sam Joshi, Joyce Ship-Freeman, Ajay Patil and via Zoom, Mayor Tomas Lankey.

#### Items Discussed:

- Edison Art Society Gloria Dittman provided the committee with an update. The Edison Art Society is in the process of collecting date for applications for Arts' Scholarships. She has shared this information with Roger Vroom, District Supervisor of Visual and Performing Arts for distribution to the appropriate students.
- Covid-19 Update Mrs. Ship-Freeman expressed concern about getting Covid-19 vaccines for the homebound and seniors who have not yet been vaccinated.
- Andrew Toth, Deputy Fire Chief/OEM Coordinator was unable to attend the meeting. He
  provided the committee with an update, stating "all School Staff and Edison Township Staff
  were offered the vaccine." His team is working to get vaccines for everyone in need in the
  Township. Seniors and homebound people are still a priority for receiving vaccines.
- A group discussion ensued regarding the availability in the community compared to other
  areas in the state. Pharmacies are getting vaccines in more populated areas like Jersey City
  and Newark. In addition, the possibility of offering vaccines to students as well in the coming
  weeks, along with offering Rapid Testing to students and staff. The District will research this
  option with their current testing provider.
- Properties Update (Overcrowding) Mayor Lankey spoke in length regarding the options of purchasing Stelton School, which is still a work in progress. Truman Avenue (Kilmer) Properties Representatives from Edison Township have contacted the Federal Government about the Kilmer Property. The Township is doing their best to move forward with the process. As soon as the Mayor gets more information, he will update the committee.
- Dr. Bragen informed the Committee that they have options for the property at Talmadge Road and Coolidge Avenue in Edison for a potential school. The options will be presented to the Finance and Facilities Committee for review, prior to presenting it to the full Board of Education.
- Suggestion Mrs. Ship-Freeman expressed concerns that more students of color are being
  placed in Level 2 classes. Dr. Bragen explained the District's efforts to raise the performance
  of all students, especially those who are students of color and that this is one of the District's
  goals.
- Suggestion Mr. Biral Patel suggested that students over 16 be sent emails regarding Covid-19 vaccines to determine if they would consider getting the vaccines if offered. Dr. Bragen said he would contact HMH-JFK to see if this is a possibility.
