# I. CALL TO ORDER/FLAG SALUTE

The January 15, 2019 Special Public Meeting of the Edison Board of Education was called to order by Board President, Mr. Jingwei (Jerry) Shi, at 7:00 P.M. at the Education Center, 312 Pierson Avenue, Edison, NJ 08837.

#### II. ROLL CALL

## VIII. DISCUSSION – ELECTION DATE CHANGE

Mr. Shi reported that earlier this week, it came to the attention of this Board that the Town Council was convening a special meeting to discuss the movement of this year's Board of Education election to April. He convened tonight's special meeting of the Board so that, as a Board, everyone had the chance to weigh in. Earlier this evening, he was informed that Council President Gomez cancelled the Town Council's special meeting.

There are a number of opinions, some in favor, some opposed, to moving the Board of Education election to April. Those in favor have expressed the benefits of the move. Those opposed have highlighted the challenges.

Tonight, Board members and the public have the opportunity to weigh in on the subject. Even though the Council has cancelled its meeting, this board can still have a discussion on this matter.

Regardless of where this ends up, Mr. Shi would like to see greater participation by Edison residents. This past election saw tens of thousands of votes cast for Board of Education candidates. We should continue to encourage that level of participation and try to exceed those numbers. When residents participate in the process, the process becomes stronger.

## IX. BOARD MEMBERS – OPEN DISCUSSION

Mr. Brescher wanted to clear up what he heard at the last town council meeting. Many people believed that the Board of Education has a loaded pot of money. Edison is in the lowest 10-percent in costs to educate students. Edison does not overspend on anything. The facts are there. The budget is put together in April and over the past summer there were over 500 new students enrolled. These students were not included in the new budget.

Mrs. Conway felt the election should stay in November.

Mrs. Moroney believes there is a spirit of cooperation with the Board of Education and the Town Council.

Mrs. Ward thanked the Town Council for cooperating with the Board of Education.

Mr. Shi stated that 2019 will be a busy year with the Superintendent Search and the Bond Referendum. He asked the Curriculum and Technology Committee to add Cricket to the curriculum, due to the demands and demographics of Edison. He also wants the Education Center to look into implementing a Student/Parent Phone Request System and to look into working with Middlesex County College to get students into the school. Mr. Shi asked the Food Service Committee to look into the complaints regarding the quality, quantity and freshness of the food served in the cafeterias. He mentioned that the Finance and Facilities Committee is in the process of getting modular classrooms at the F. D. Roosevelt School and roofing issues are being looked into, along with the possibility of adding solar panels on many roofs. A new transportation software package is being implemented and the Board is looking into security tracking devices for all buses. The Policy Committee will update some of the outdated policies. The Special Education Committee had many complaints and will make sure the students are getting the best services. The Community Relations Committee plans on working with the community to listen to their needs.

Mrs. Moroney spoke about the Wingman Program at James Monroe Elementary School and explained how the fifth graders were teaching the first graders. She also met with the student at John P. Stevens High School who encouraged the district to use biodegradable trays for lunches. This student is now working on a plan to have students separate their garbage into categories.

Mr. Errico questioned a holiday request from Mrs. Patel. This matter is being researched by the Superintendent's office.

Mr. Shi reported that the Board will hire a search firm for the Superintendent Search and he is asking the attorney to send out an RFP for a search team.

# X. PUBLIC COMMENTS

Carol Bodofsky, resident, discussed the history of the election process.

Matt Hrevnak, ETEA Vice-President, felt moving the election would have a negative effect on the Board of Education.

Maria Orchid, resident, invited everyone to attend Junior College Night at Edison High School on Thursday.
