1. Finance & Facilities Committee

Mrs. Conway reported that the Finance and Facilities Committee met at 3:00 P.M. on April 2, 2020 remotely through ZOOM.

In attendance were: Elizabeth Conway, Ralph Errico, Beth Moroney, Shivi Madhukar, Bernard F. Bragen, Jr., Ed.D. and Daniel P. Michaud

Items Discussed:

- The Committee discussed the district's different options following the defeat of the March 10, 2020 referendum. The options discussed included a third attempt for a reduced scope of work in September, appealing to the state for the needed additions or funding some additions through the annual budget, and, if needed, apply for a short-term lease purchase.
- The Committee discussed the district's current plan regarding the staff, including what positions are being paid and which positions are not being paid, along with the rationale for each. The Superintendent explained how each paid position was accomplishing their work, some on site and some remotely. The staff that cannot provide their job related duties will not be paid, such as the lunch aides, bus aides and some bus drivers.
- The Committee discussed the currently proposed 2020-2021 school year budget. Various aspects of the budget were discussed in detail and the committee asked the administration to provide several alternative reduced budget options that can be considered. The Committee agreed to have a follow-up meeting on Wednesday, April 8th at 3:00 P.M.

The meeting adjourned at 4:15 P.M.

2. Finance & Facilities Committee

Mrs. Conway reported that the Finance and Facilities Committee met at 3:00 P.M. on April 8, 2020 remotely through ZOOM.

In attendance were: Elizabeth Conway, Ralph Errico, Shivi Madhukar, Bernard F. Bragen, Jr., Ed.D. and Daniel P. Michaud

Items Discussion:

- The Committee reopened discussions about the currently proposed 2020-2021 school year budget.
- There were discussions regarding numerous proposed budgeted expenditures, including staffing needs and capital projects.
- The administration explained the rationale for all of the proposed new staff.
- After further discussions, the Committee decided to cut eleven proposed positions from the budget.
- The next focus was the capital outlay budget, which included a \$13 million addition to Lincoln Elementary School This figure was the same cost estimate that was included in the failed bond referendum.
- After discussing the project, the Committee decided to reduce the allocation by \$4 million. This could be accomplished by either reducing the scope of the project or by waiting until the bid is received. In the event that the bid exceeds the budget, the district can consider a short-term lease purchase or the use of the district's capital reserve.
- The revised budget, with a nearly \$5 million reduction, has been prepared and forwarded to the Board for their review and comments. The Committee feels that this is the budget required to maintain Edison's high quality educational programs and to ensure that we can provide a thorough and efficient education in accordance with NJ statutes.

The meeting adjourned at 3:50 P.M.
