XI. <u>COMMITTEES</u>

1. Finance & Facilities Committee

Dr. Heelan reported that the Finance and Facilities Committee met on May 5, 2015 at the Education Center.

In attendance were: Deborah A. Anes, Jerry Shi, Theresa E. Ward, Dr. Frank Heelan (Board Members), Dr. Richard O'Malley (Superintendent), Daniel P. Michaud (Business Administrator/Board Secretary), Frank Messineo (Solutions Architects) and Ken Karle (LAN Associates – Architect)

Discussion:

- Mr. Messineo reviewed the summer projects, specifically boys and girls locker room renovations in John Adams and Woodrow Wilson Middle Schools and John P. Stevens High School. To accommodate the increased enrollment in John P. Stevens High School, 100 additional 18 inch wide double tier lockers will be installed.
- The Four trailers to be relocated from New Brunswick to John P. Stevens High School (3) and the FD Roosevelt School (1) have been stalled due to the cost of transporting them. The Board is seeking to get reasonable cost bids from Scotsman and Vanguard for this project.

- Solutions Architecture will be coordinating the work for the John P. Stevens High School greenhouse and, while substantial grants have already been contributed for this project, more non-board funds are needed to commence construction.
- Mr. Karle is working to secure DEP approval for Menlo Park Elementary School, and longer term, to satisfy requirements for the wetlands at Woodbrook Elementary School.
- Ten companies bid on the reconstruction of James Monroe Elementary School with a range from \$19,645,000 to \$27,200,000. Dobco, Inc. from Wayne, New Jersey was the lowest bidder; and after being analyzed by Mr. Karle and Board Attorney, Douglas Silvestro, Dobco met the specifications, and was recommended to be approved by the Board of Education for the \$19,645,000 bid.
- Seven firms submitted proposals for construction management services with a range from \$250,768 to \$834,912. The Committee will use several criteria to interview three construction management companies on May 11, 2015 at 1:00 P.M. in the Education Center. New Road Construction from Cherry Hill, New Jersey; Epic from Piscataway, New Jersey and Grayhawk from Mount Laurel, New Jersey.
- The James Monroe Elementary School Ground-Breaking Ceremony will be held on May 15, 2015 at 1:00 P.M.
