Roller Skating Lessons begin on May 20, 2022

LEVELS ———

Tots: *(ages 5 and 6)*

Never skated before or has minimum experience. Can march across the floor and get up. Two-foot glide and forward swizzle. Can skate across the floor. Swizzles, gliding.

Beginner through Delta: *(ages 7-14)*

Pre-Alpha: Cannot skate or never skated before. Scooter pushes, two-foot glides, v-walk, heel stop, forward and backward swizzle.

Alpha A:

Spin stop, one-foot glides, forward stroking, parallel turn and forward crossovers (both directions).

Alpha B:

For students who have taken Alpha A and need additional instruction.

Beta: Backward crossovers (both directions), backward stroking, two-foot mohawk and 33 turn.

Gamma: Forward outside 3-turns, forward inside mohawk and lunge stop and forward outside edges.

Delta: Forward inside 3-turns, inside edges, two-foot jump, lunges, power stop and spread eagles.

Adult 1:

Never skated before.

Adult 2:

Moving two-foot turns, crossovers, forward edge rolls and backward one-foot glide.

Adult 3: Forward and backward crossovers (both directions) and power stop.

Skater understands that lessons may be provided by independent parties and that the County of Middlesex is not liable or responsible for such independent parties.
