

I. CALL TO ORDER/FLAG SALUTE

The June 18, 2018 Public Meeting of the Edison Board of Education was called to order by Board President, Mr. Jingwei (Jerry) Shi, at 7:00 P.M. at the Education Center, 312 Pierson Avenue, Edison, NJ 08837.

VII. PUBLIC COMMENTS (RESOLUTIONS ONLY)

Elizabeth Conway, resident, questioned items on the Personnel Agenda.

Beth Moroney, Board Vice-President, reported: "Five years ago on a cold March Saturday night, the James Monroe School burned down. Due to the fast action of Middlesex County College President, Joanne Morales, the students of Monroe were back in class by Wednesday of that first week after the fire.

On Monday evening after the fire, Dr. O'Malley called a meeting of the parents, students and teachers of James Monroe School. Dr. O'Malley assured all present that there would be swift action towards remediating the problem of the moment, getting the kids back in school and figuring out the long range problem of rebuilding a school.

Our insurance company at the time, the New Jersey Schools Insurance Group, a joint insurance fund, presented the district with a check for \$1million, given in good faith that a fair settlement to rebuild the school would be coming shortly. The check brightened everyone's mood. However, NJSIG's offer to Edison to rebuild James Monroe was \$9 million, the cost of the school when it was built 50 years before.

The disparity between NJSIG's first offer and the district's dire need to raise \$18 million forced us to go to a bond referendum, which the residents of Edison did pass, and ultimately a lawsuit waged against NJSIG.

It is hard to forget the many long and late board meetings that we held trying to figure out how we could get enough money to break ground. This caused a delay in the building of the new James Monroe. Even when the final offer was given to us, \$19 million, there were board members who argued to hold out for the full \$23 million.

After the delay due to the law suit, the Barclay Group, our Risk Management Insurance Broker for 11 years, managed to get Edison a unique insurance program, the SAIF, for Edison; whereby, Edison has \$400 million of dedicated property insurance for Edison's 1,750,000 square feet of building/structures content. Under this insurance plan, Edison was not in a pool with any other district.

Since removing the Barclay Group as our Risk Management Broker, and giving this over to the Alamo Group, without even allowing Barclay to even make a presentation to the Board, the proposal before us tonight is to return our business to the New Jersey School Insurance Group.

Although their representatives came before the Board on Thursday night, and told us of the things that they have changed in business practice since learning from their mistakes with the Monroe fire, I keep thinking of the angst that the three of us who were on the Board then, Dr. O'Malley and Mr. Michaud went through at that time.

Supposedly going back to NJSIG will save the Board \$250,000 a year. While this is a sizeable chunk of money, I want to remind everyone that we had to pay rent to St. Cecilia's of almost a million dollars when our new building couldn't open on time. So, I figure it will take nearly four years of savings of \$250,000 to make up the loss to the district because we spent precious time fighting NJSIG in court.

Shame on the Edison Board of Ed for even allowing these people to talk to us again. They have proven to us under the most desperate of circumstances how much they care about the children of Edison. Shame on Mr. Alamo for not realizing the depth of pain and anxiety that NJSIG caused us. They don't care about us – they just want our very lucrative business- and remember: Fool me once, shame on you. Fool me twice, shame on me.”

Bret Baker, resident, approved the change to NJSIG.

64. Resolution to Use Savings From Insurance Procurement to Address Overcrowding in the Schools

1. Finance & Facilities Committee

Items Discussed:

- Luis Alamo and Kathy Young of the Alamo Insurance Group presented their recommendation for the 2018-2019 risk insurance for the district. Their proposal is to contract with the New Jersey Schools Insurance Group with an estimated annual savings of \$268,000.
- Dr. O’Malley presented his recommendation for the 2018-2019 salaries for the district’s exempt personnel.
- The committee discussed a proposal for rolling over the previously purchased Apple MacBook Air computers. The existing three year old computers would be turned over for approximately \$1.7 million and applied towards the purchase of new high speed MacBook Air 8 GB computers.
- The committee discussed their expectations of the approved performance audit that will be provided by Wiss & Co.

2. Security Committee

XI. BOARD MEMBERS – OPEN DISCUSSION

Mrs. Moroney asked if she will be included in the Interview Committee for the Superintendent Search. She also read the following: “It has been six weeks since Dr. O’Malley tendered his resignation to the Board and we accepted it. During those six weeks, Mr. Shi asked each Board member to submit a list of qualifications we are looking for in a Superintendent.

“I was looking forward to the entire Board having a conversation on our suggested list of qualifications, as well as an opportunity to prioritize what qualities are at the top of the list.

“Several members of the Board asked Mr. Shi when he was going to ask for the job to be posted. When I asked, Mr. Shi gave me excuses as to why he was waiting, but in all that time there was not one conversation held with the nine of us.

“One day Mr. Michaud even asked Jerry when the ad would be placed and Jerry waved Dan off. In those six weeks, as previous time was ticking away, nothing happened. Yesterday an ad finally appeared in the Star Ledger. (She read the ad).

“Now this ad emphasizes that time is of the essence to get the applications back. They are to be submitted by July 1. Also, note that the applicant should have experience as an interim superintendent. This ad directs applicants to send their applications to the law firm. I have consulted with several lawyers and the Middlesex County Superintendent on the unusual procedure. What I have been told by all of them is that the Board Attorney is hired to give legal advice; not to interfere in the search for an employee. Mr. Shi did this of his own volition.

“Just as the full Board never spoke together to discuss the dismissal of our previous law firm, the Board has not talked about the process of hiring a Superintendent. Like all things Mr. Shi does, he is dictating the process that he wants to keep control of. Even though Mr. Shi says the applicants will have their names blocked out and screening will be blind, I believe that a pre-screening will be held.

“We are coming dangerously close to still more ethics violations. Mr. Shi has remarked to several people, including me, that a Superintendent is more important than a mayor. If this is so, I charge you with inviting all nine members to be part of the screening process from Day No. 1 – All nine, not just your four puppets, Mr. Shi. All nine.”

Mr. Distefano questioned the Superintendent overlap.

Mr. Brescher discussed the applications going to the attorney before the interviews.

Mrs. Ward stated that Brandon Uhlig’s exit from the Edison Schools is a loss to us all. For the better part of eight years Brandon has been the sights and sounds of the children, educators, and board of education proceedings and has done so with appropriate class and commentary. She told him that all shall miss him.

Mrs. Ward reported that each year in the Finance Resolutions the Board is asked to join the NJSBA for the ensuing year, along with recommendations that they “are encouraged to partake of the various workshops and services offered by the NJSBA.” Under reasonable conditions, belonging to and partaking of our professional association would be unquestionable.

However, she continued, what is not mentioned and reasonable is the assessment to the Edison Board of Education for these dues, convention and partakings. Dues are \$26,662.70 (the highest in the state), the convention fee is \$1,500 – up 66% from the \$900 when she became a board member and this part year the Board paid \$998 for a few board members to partake of the association meetings. That gives a total of \$29,160.70 in assessments for the past ten months, not one dollar of which is up for a vote.

In checking their schedule of offerings for the past year, if one board member partook of each of their offerings, it would cost the board (i.e., taxpayers) \$2,366. Multiply that by the nine members and they would have spent a whopping \$21,294, just for the partaking.

If she wanted to attend a meeting and there is a fee, she refrains from partaking, and no doubt, misses a few opportunities.

In 2016 the board voted to not pay dues until they had a meeting with the field service representatives. They came, we met, and we proposed that there be a flat membership fee or that membership be voluntary. They promised to consider our request; they left; and nothing has been heard from them since.

Within the past 2 ½ years the Edison Board sent 2 resolutions to be considered by the SBA – State Aid and Charter Schools. Both were rejected “by the committee.” We asked that the charter schools resolution be considered by the full membership at the Delegate Assembly meeting. She addressed the membership, enumerated their concerns, and asked for a vote. Discussion consisted of one favorable response before someone (a plant) made the motion to table and return to committee. Their rejection letter began, “After much consideration...” Mrs. Moroney and Mrs. Ward asked to have the two sit in on the committee deliberations since it is the same committee that rejected it in the first place. It has been 1 ½ years of silence. No response.

Prior to the Delegate Assembly meeting she asked to speak with someone who could guide her in the procedures. A most cooperative executive committee member did speak with her until she asked him if there was a possible conflict of interest regarding charter schools on the part of NJSBA since they collect dues from and represent charter schools, at which point he looked at his watch and said he had to go. No answer. Although she mentioned this possible conflict of interest when she addressed the general assembly, it was not in the report.

Mrs. Ward stated that the NJSBA has five lobbyists in Trenton paid for with our dues. We have none. Our legislators should be our advocates; however, I don’t see any evidence of their support, either. Despite our trip to Trenton, protests, petitions, and pleadings; we are still saddled with PARC, common core, short millions per year in state aid, indiscriminant passes for charter schools, and exorbitant dues and fees to NJSBA. When the NJSBA takes action, it is more often than not weighted against our interests. This charade of caring should be put to a halt. They don’t care.

Again, she said that she would like this board of education to wake up and take a stand. They can start with reversing their membership and not paying dues. I.E., go to meetings, workshops, conventions, etc. as nonmembers. She knows her annual rant is considered laughable by some. She, however, is still serious.

Mrs. Prasad-Madhukar thanked Mr. Uhlig for his service to the students of Edison.

XII. PUBLIC COMMENTS

Dr. Frank Heelan, resident, thanked Dr. O'Malley for his service to Edison and congratulated him on his future endeavors. He felt Mrs. Moroney should have a more active role on the Board. He was also concerned with the many changes being made. He also congratulated Woodbrook School on their new addition and stated that Lincoln School has the most need in the district.

Elizabeth Conway, resident, was proud that the board hired back four non-renewals and spoke about the John P. Stevens grant.

Bill Brunner, resident, spoke about the importance of the Superintendent.

Matt Hrevnak, ETEA Vice President, stated that the Superintendent is the most important person on the Board. He spoke about the ENRA Dinner, rehires and the technicians.

Mr. Patel, resident, questioned the safety at bus stops.

Brett Baker, resident, discussed weapons.

XII. ADJOURNMENT

There being no further questions or comments forthcoming, Mr. Shi asked for a motion to adjourn this June 18, 2018 public meeting of the Edison Board of Education at 9:07 P.M. Mr. Brescher made the motion, seconded by Mr. Distefano and approved by all members present.
