# BE IT RESOLVED: as follow:

- 1. The Board hereby approves the following Superintendent's merit goals in a total amount of \$29,467.95 for submission to the Executive County Superintendent for approval:
  - i. Computer Science The New Jersey Student Learning Standards include topics related to computational thinking. The goal is to increase the enrollment in computer science classes by 10% overall in grades 6-12, through planning, acquisition of grant funds, and professional development.
  - ii. Math By the end of the 2018-2019 school year, 90% of teachers (K-5) will increase their understanding of how to support the conceptual understanding of Math by 1 unit as measured by a pre and post rating survey given to teachers.

- iii. English Language Arts PARCC Test Increase the percent passing of EHS Grade 10 students by 10% from 48% passing in 17-18 to 58% passing in 18-19 on the English Language Arts PARCC test or its equivalent.
- iv. Referendum By June of 2019, the Superintendent will develop and submit a district referendum plan to the Department of Education. The plan will be in alignment with its Long Range Facilities Plan. It will provide sufficient, high-quality instructional spaces to meet growing student population and demographic needs. #### XII. <u>COMMITTEES</u>

1. Curriculum & Technology Committee

Mrs. Prasad-Madhukar reported that the Township Liaison Committee met at 2:00 P.M. on November 16 and December 10, 2018 in the Education Center, 312 Pierson Avenue, Edison, NJ 08837.

In attendance were: Deborah Gulick, Baninder Mahabir, Shivi Prasad-Madhukar, Shannon Peng, Richard Brescher, Beth Moroney and Falguni Patel (November meeting only)

- Presentation: Out Run Your Fork
  - Mr. Bianchino from OutRunYourFork presented an overview of his program and will follow up with Mr. Hristofis, Supervisor of PE and Health about the possibility of including his product in our curriculum.

- Curriculum Updates Elementary
  - Teacher Observation Program at John Marshall School Mrs. Mahabir shared that a committee of teachers and administrators have begun working on K-2 report cards. The report cards have not been updated in 17 years. The committee is researching and meeting every month.
  - Math K-5 Implementation & Professional Development Updates Mrs. Mahabir shared the investment that has been made in professional development for the implementation of the math program. She discussed the success of the building based small group professional development sessions that have been going on. She discussed the differences between the TenMarks program and the Investigations program, highlighting the hands on component of Investigations. She also indicated they are looking for a possible supplement for the 2019-2020 school year.

• Language Arts Pilot Grades 1-5 – Mrs. Mahabir shared that teachers volunteered from four schools to pilot two different Language Arts Programs: Fountas & Pinnell and collaborative Literacy from December 3 through February 1. Training for these pilot programs has been arranged. Teachers visited other school districts using one of the products. Mrs. Mahabir explained that the programs have very little online requirements. She updated that the Collaborative Literacy pilot has begun.

- Textbooks:
  - Overview of inventory and subscriptions: Mrs. Gulick reviewed the subscriptions of many of our texts and discussed plans for pilots and budget plans in order to include both text and online access to our resources. Subscriptions are expiring in the following subjects, and pilots have been scheduled:
    - HS Algebra II Honors 2 schools piloting 1 text begins in December
    - HS Social Studies 2 schools piloting use of iBooks
    - MS Social Studies 4 schools piloting 2 publishers
    - MS Math 4 schools are choosing from 3 vendors
    - MS Science 4 schools are piloting 2 publishers

• All teachers are being trained by publishers and meeting together in December. Pilots will take place beginning in January for the following subjects: Students will be surveyed in the coming months.

• PSAT 8/9 Updates/Questions and Grouping Procedure Communication:

• November: Questions were answered regarding the commitment with the College Board to administer the PSAT 8/9 and the reasons why this assessment was selected as an alternative to iReady. The PSAT 8/9 results will be used as part of the criteria for grade 9 placement.

- December: Approximately 1200 students took the PSAT 8/9 on December 4<sup>th</sup>.
  - The PSAT 8/9 was selected for the following reasons: (1) it is a nationally normed test which gives parents and teachers information about students' readiness in college level skills when compared with grade eight test takers across the country; (2) it gives students a preview of high stakes high school tests, including the PSAT and the SAT and (3) it was administered in 1 three-hour block using paper and pencil, giving us more instructional time (the iReady required as many as 13 days to administer).
- Scores will range from 120-720 on each section of the test
- Scores are expected in February
- Students will receive their test booklets and answers which they may use for future learning
- PSAT 8/9 scores will be one piece of the grouping procedures used to move students up into higher level courses in English and Math at grade 9; other criteria include grades in the course, performance on district assessments and teacher recommendations

- Professional Development Day Feedback November 6 Both elementary and secondary sessions received positive feedback. Plans for next year's focus will begin in the spring.
- New courses are being developed; details will be finalized in January. High School Social Studies/English elective in American Studies; AP Computer Science Principles will be offered; A computer literacy elective will be offered at the middle school
- Coaching Proposal: Ms. Mahabir reviewed proposal for additional coaching in schools.

The meeting adjourned at 3:30 P.M.

# 2. Finance & Facilities Committee Meeting

Mrs. Ward reported that the Finance and Facilities Committee met at 4:00 P.M. on November 28, 2018 at Education Center, 312 Pierson Avenue, Edison, NJ 08837.

In attendance were: Jingwei "Jerry" Shi, Theresa Ward, Richard Brescher, Daniel Michaud, Paul Saxton, Ken Taylor, Ralph Barca and Richard Benedict.

Items Discussed:

- The Committee discussed the improvements planned for the old gymnasium at John P. Stevens High School. The improvements include roof repairs, floor refinishing, light fixture upgrades and possibly replacing the old bleachers.
- The committee reviewed the current substitute custodians hourly rate which is \$10.50 per hour. The Committee is recommending that this rate, that has not been increased in over ten years, be increased to \$15.00 per hour to be competitive with neighboring districts and due to the fact that we are having difficulty hiring substitute custodians.
- The Committee reviewed the daily substitute teacher rate which is currently \$80 per day for county certified substitutes and \$90 per day for state certified substitutes. The Committee is recommending that the state certified substitute rate be increased to \$100 per day to help attract more state certified substitute teachers.
- Ralph Barca and Rich Benedict explained the need to purchase a server to house the Genesis software. The district needs to expand its virtual server farm for processing and storage. Mr. Barca will investigate the possibility of a cloud based solution with Amazon or Microsoft.
- The Committee is recommending that Ken Taylor, who has been the Acting Director of Buildings and Grounds since July 1<sup>st</sup>, be given the position of Director of Buildings & Grounds based on his exceptional performance over the last five months.
- Mr. Taylor presented a report of maintenance projects that have been completed since July 1, 2018.
- The Committee discussed the modular classroom project that is scheduled to be added to the F. D. Roosevelt School to be ready for the 2019-2020 school year.
- Tom Rienzi, the District's roofing architect, provided an update of the roofing replacement plan for several schools. The bid specifications are nearly ready to be advertised. The roofing work is scheduled for the summer of 2019.
- The Committee discussed an alternative to traditional roofing which is a sprayed on roofing material along with the possibility of installing solar panels on some of our schools.

# 3. Overcrowding Taskforce Committee Meeting

Meeting Date: November 29, 2018 - 7:00 P.M. Location: Education Center, 312 Pierson Avenue, Edison, NJ 08837

Mr. Ralph Errico, Chairman, welcomed everyone and thanked them for attending the meeting.

Mr. Errico introduced SSP Architect's Planning Team members: Jeanne Perantoni, who will lead the project for the Educational Long Range Planning, and Heather Wilkerson, the Project Manager. They presented a power point regarding the Long Range Facilities Master Plan and the planning process overview.

Ms. Perantoni reported that George Sundell of Sundance Associates will be preparing a new demographic study for Edison.

Ms. Wilkerson reported that she has been assessing the sites and compiling the information on all schools.

Ms. Perantoni discussed the planning process, the planning needs and the areas of focus. She presented the preliminary finds on the increase in enrollment in all Edison schools over the past five years.

Items Included:

- The demographic impact will shift to Middle and High Schools over the next five years.
- Special Education needs are expanding, despite the decrease in birth rates.
- Special Education population will continue to impact facility spaces at all grade levels and will significantly grow in size at Middle and High Schools.
- Class sizes are increasing, especially in Grades 4 to 8.
- Limitations in space for special activity rooms are impacting both program delivery and opportunities for student access.
- Security and safety upgrades are needed to improve access and supervision.
- Site development additions and alterations are needed to expand capacity, eliminate trailers, secure entrances, and support year-round community use.
- Site development improvements are needed to separate cars and buses, enhance circulation, pickup and drop-off and mitigate flooding.

Public discussion and questions included:

- Will the health offices be looked at throughout the district, since many have no private space for the nurse and a few are too far from the main office?
- Will the sidewalks around the schools be addressed?
- Safety in hallways and stairwells
- Water quality in the drinking fountains
- Will all schools have air conditioning?
- Will alternatives in the planning process be looked into?

The meeting ended at 7:45 P.M.

# 4. Transportation Committee Meeting

Mrs. Patel reported that the Transportation Committee met on December 12, 2018 - 10:00 A.M. in the Education Center, 312 Pierson Avenue, Edison, NJ 08837

In attendance were: Richard Brescher, Falguni Patel, Theresa Ward, Daniel Michaud, Paul Saxton, Cheryl Roxlau, Lisa Errico and Jim Burke

#### Discussion:

- The Committee discussed several parental requests for bus stop changes. The Transportation Department will review the current bus stops and if they cannot be changed this year, they will be considered for a change in the next school year.
- The Committee discussed the current board policy for subscription bussing. The policy states that the cost of the subscription bussing program must be self-sustaining wherein the subscription bussing fees must cover the cost of the program. With the increasing cost of transportation over the last several years and the fact that the subscription bussing fee of \$500 has not been increased in over 15 years, the Board must consider an increase in the subscription bussing fee for the 2019-2020 school year.
- The Committee discussed the lack of applicants for vacant driver and bus aide positions. The Board had negotiated a collective bargaining agreement with the drivers and aides that made their compensation very competitive but we are still not able to attract viable candidates for the jobs. The advertisements that are placed in the newspaper about vacant positions were reviewed and the committee is recommending that the district place an ad specifically for drivers and aides and that the ad includes the starting salary and benefits that the District provides.
- The Committee discussed the implementation of the "Versa-Trans" transportation routing software. The information gathering for the conversion is nearly completed and the training of the staff will take place in January. The current software program, Tripps, will run simultaneously with Versa-Trans until the district is satisfied that the new program is running accurately and efficiently.

The meeting ended at 11:55 A.M.

# X. <u>BOARD MEMBERS – OPEN DISCUSSION</u>

Mrs. Moroney commended everyone involved in the Wingman training program.

Mr. Errico discussed the SLEO Agreement. He also thanked Mr. Saxton for providing VIP Cards to the Senior Citizens of Edison. Mr. Errico felt that all staff members should be recognized for working late on the snow day and wished everyone a happy holiday.

Joseph Johnson, resident, discussed the 8-week mentorship program he is giving at John P Stevens High School. His parents were there to commend him for the work he has been doing with this program.

Elizabeth Conway, resident, encouraged Mr. Johnson for the work he is doing. She applauded Mrs. Moroney and the Wingman program and commended the two high schools for their winter concerts.

Carol Bodofsky, resident, thanked out-going board members, Mrs. Prasad-Madhukar and Mr. Distefano for all they did for the students of Edison.

Bill Brunner, resident, discussed the overcrowding in the schools and asked if there will be a Bond Referendum in the spring.

Anthony DeAmorin, resident, suggested getting the mayor involved in the overcrowding problem. He asked for new leadership on the new board in January.
